- d. Indicate comprehensive job chart and terms and conditions to CEOs / Directors / Technical persons under intimation to all the concerned.
- e. Constantly appraise Hon'ble Chief Minister and esteemed Chief Secretary about performance and results of CEOs, Directors and Technicians.
